ATTEMPTS THROUGHOUT THE YEAR

In 2023, the CFA exam will take place:

- 4 times for level 1 - In February, May, August, and November
- 3 times for level 2 - In May, August, and November
- 2 times for level 3 - In February and August

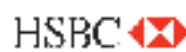

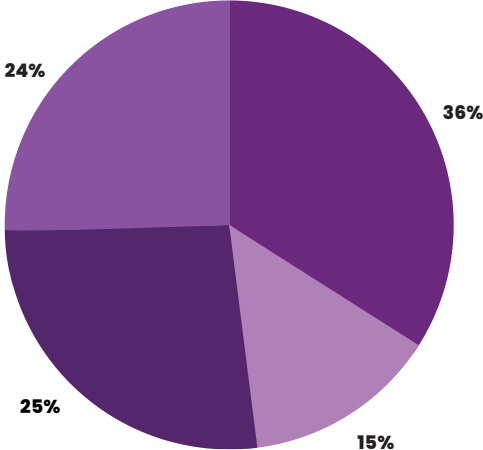
